# Message From The Chair Helen Burstyn



It is an extraordinary honour to serve as Chair of the Ontario Trillium Foundation (OTF). My admiration for the Foundation has grown ever greater since I first joined its Board of Directors five years ago.

OTF grants and volunteers are having an incredible impact everywhere in the province. For everyone associated with OTF, the work of the not-for-profit organizations we support inspires us in our mission of building strong and vibrant communities across Ontario. This year, once again, there were countless examples of innovation, creativity and resilience as not-for-profits – large and small, established and emerging, rural and urban -- met the many challenges facing them during tough economic times.

The OTF Future Fund program is a great example of some of the groundbreaking grants we made this year. Our capacity-building work in the environment sector is gaining momentum through a second Future Fund investment of \$2 million. Encouraged by the initial outcomes of the 2007 Future Fund environment grant recipients, OTF anticipates continued growth in this important and underfunded sector. To date OTF has invested \$4 million to promote collaboration and build leadership in the environment sector through this fund.

The Future Fund also granted \$2 million to organizations working together to break down barriers to employment and formation of social enterprises. In the face of a failing economy, the Fund's strategic focus is both relevant and timely as it supports projects that are creating innovative economic opportunities for Ontarians.

We are pleased to enjoy the continued confidence of the Ontario Government, which once again invested in the Foundation with a second annual budget increase in spring 2008. The boost in our funding from \$105 million to \$110 million will help OTF make an even greater impact in Ontario communities.

In 2008-2009, the Foundation invested \$104,596,300, in 1,484 grants to charitable and not-for-profit organizations in our four funding sectors across the province: We have:

- Contributed more than \$43.4 million to grants in the human and social services sector;
- Supported the sports and recreation sector with more than \$23.3 million in grants;
- Invigorated the arts and culture sector with more than \$24.6 million in funding; and
- Dedicated more than \$15 million to the not-for-profit environment sector.

OTF appreciates that the people of Ontario are diverse and dynamic, and that community needs differ across the province. Our approach is inclusive and our support for innovation is genuine. We continue to expand our knowledge of ethnic and marginalized communities in Ontario in many ways. Our ethnic media roundtables are already helping us to better understand the needs of cultural groups across the province.

I am grateful to the volunteer Board of Directors and Grant Review Team members who serve alongside me. Their support and dedication is vital to the Foundation's success, and I am honoured to be in such good company.

I would like to also recognize the Honourable Aileen Carroll, Minister of Culture, for her unwavering support of OTF and the communities we serve throughout Ontario. She demonstrates her support to the Foundation time and again when she attends the many events recognizing our grantees and community partners.

The OTF staff, led by CEO L. Robin Cardozo, has some of the most talented and dedicated professionals I have had the pleasure of working with. I salute their commitment and contribution to the Foundation's work, and their exemplary sense of public service.

Not-for-profits are the unseen hand that keeps Ontario afloat, in good times and bad. As the demand for services increases and the sector faces new pressures, I have no doubt that the Ontario Trillium Foundation is well-positioned to play a leading role in building an even stronger Ontario.

## Message From The Chief Executive Officer L. Robin Cardozo



We live in extraordinary times in a world that requires us to constantly learn and adapt. From changes in technology and the way we communicate to a stumbling economy, challenges and opportunities present themselves daily, and through it all there is no question that Ontario's not-for-profit (NFP) sector plays a vital role in keeping our communities healthy and vibrant.

The Ontario Trillium Foundation (OTF) remains steadfast in its mission to strengthen the voluntary sector through investments in community-based initiatives. This year we played an active leadership role within the NFP sector, providing knowledge and opportunities for groups to share with one another.

Our commitment to knowledge sharing is evident in the Foundation's continuous research work. Both timely and relevant, OTF research is helping position the Foundation as a knowledge leader. We were pleased to present the Your Community in Profile reports which feature recent demographic data from Statistics Canada. The unique data is helping NFP organizations, municipalities and governments to anticipate change, address future needs and manage solutions within Ontario communities and the province overall. The reports also help to inform the Foundation's grantmaking to ensure community needs continue to be addressed.

In response to recent economic concerns, OTF had in-depth conversations with more than 100 NFP organizations large and small representing all NFP sectors we serve. Respondents in this study, aptly called Challenges and Opportunities in the Economic Crisis, asked OTF to take on a greater role in sharing best practices and in convening groups within the sector. We successfully hosted our first webinar and online discussion forum to highlight key findings from the study.

Continuing our work to streamline the Foundation's granting and administrative processes, we were excited to pilot the new online application process in two of our funding regions this year. Applicants in Thames Valley and Champlain were pleased with the user friendly online platform, which featured fewer application questions. The positive feedback was extremely encouraging. We are well on track to providing online grant application and review services to all of Ontario by 2010.

As always, I am extremely grateful to our volunteer Board of Directors and Grant ReviewTeam members whose commitment and passion to serving their communities has been instrumental to the Foundation's continued success. I would also like to express my thanks to OTF Chair Helen Burstyn, whose dedication and energy inspires us all.

The staff at OTF is a talented and engaged group of professionals who continue to raise the bar of excellence. I am honoured to lead them and appreciate their unwavering support in the Foundation's work.

This year was a very special year for 36 members of staff who achieved more than 10 years of service with OTF. I am proud of this impressive accomplishment and the collaborative, supportive work environment that has played a part in this success. We were pleased to be able to celebrate this important milestone in early 2009.

As we forge ahead, we know the journey will not be a smooth one. The strength of the not-for-profit sector will be tested as organizations adapt and respond to a changing economic climate. OTF has an important role to play at this time. We will continue to rally the sector and provide the knowledge and resources necessary to strengthen Ontario's communities.

## ACCOUNTABILITY, IMPACT AND ORGANIZATIONAL EFFECTIVENESS Ontario Trillium Foundation Review of 2008-2009 Achievements

The Ontario Trillium Foundation Business Plan for the year covered three major performance goals, each with supporting objectives. The following summarizes the organization's achievements relative to those goals and objectives.

# GOAL 1: Make investments to build healthy and vibrant communities and strengthen the capacity of the voluntary sector

#### **OBJECTIVE 1: Make grants to achieve priorities**

#### **Achievements:**

- Allocated 100 per cent of the year's granting budget, by granting program and by catchment area, subject to modest variations.
- Achieved granting targets within sector allocation ranges by granting 24 per cent of funds in the
  arts and culture sector, 13 per cent in the environment sector, 41 per cent in the human and social
  services sector and 22 per cent in the sports and recreation sector.
- Significantly increased OTF granting in the environment sector: over the past three years granting in this sector has grown from \$7.6 million (2005/06) to \$13.2 million (2008/09).
- Achieved granting targets in the four granting priority areas. Granting under the "enhanced employment and economic potential" priority doubled over the previous year, to \$14.0 million.

#### **OBJECTIVE 2: Enhance the impact of OTF grants**

#### **Achievements:**

- Published the results of Small Towns: Big Impacts, a research study to assess the community-wide impact of OTF grants.
- Continued work on a multi-year project to determine measures of healthy and vibrant communities, including stakeholder and community consultation. Initial results of this comprehensive research will be presented and discussed at the OTF Professional Development Conference in November 2009.
- Worked to enhance the long-term impact of Ontario's not-for-profit sector through grants for organizational capacity building, and began work on a comprehensive review of the impact of this funding.




The Kapuskasing Nordic Ski Club, the Remi Ski Hill in Moonbeam and the ski-hill lodge in Kapuskasing have all helped revitalize the local economy in their community

 Entered into a partnership with the Ministry of Citizenship and Immigration, to improve the capacity of Ontario's voluntary organizations, with particular emphasis on small and mid-sized groups outside urban centres. • For every \$10.00 granted over the past three years, leveraged an additional \$17.50 in volunteer time, in-kind contributions and direct funding from other sources.

#### OBJECTIVE 3: Strengthen the Foundation's role as a leader and convenor

#### **Achievements:**

- Continued implementation of the Foundation's knowledge management strategy, the cornerstones
  of which are new plans for research, knowledge sharing, convening and communications that will
  extend the Foundation's role in providing support to the not-for-profit sector beyond its granting
  dollars.
- As part of a new convening plan, significantly increased activity under this objective, bringing grantees, other stakeholders and Foundation staff and volunteers together in areas identified as priorities for OTF, including Aboriginal groups, northern and rural communities and organizations in the environment sector.
- Produced Your Community in Profile a series of 17 customized statistical reports on economic, social and demographic trends in Ontario, based on data drawn from the 2006 Census results – in order to help not-for-profits and their funders address emerging and future community needs.

 Not-for-Profit Sector during Tough Economic Times. This report is the result of interviews with
 more than 100 Ontario not-for-profit organizations in what is the first phase of a multi-phase project
 to work with the sector and with other funders to better understand and react to the impact of the
 recession.

#### **OBJECTIVE 4: Enhance the equity and accessibility of OTF funding**

#### **Achievements:**

- Carried out targeted outreach to encourage grant applications from under-serviced and underprivileged populations, including Aboriginal, Francophone, ethnocultural and racial minority, northern, and rural groups, and groups in urban priority neighbourhoods.
- Significantly increased granting to First Nations, Métis and Aboriginal communities: over three years, funding to these communities has grown from \$3.0 million in 2005/06 to \$8.2 million in 2008/09 (not including grants that serve multiple communities).
- Adjusted the Community program funding formula to reflect the most recent Census data.
- Continued to focus on increased capital grant funding in lower budget catchment areas.

# GOAL 2: Implement the results of the Board's 2005-2007 strategic review and initiate a review of the Foundation's Strategic Positioning

#### **Achievements:**

- Completed implementation of strategic review decisions, including \$2 million in additional funding for the Future Fund and funds for enhanced capital granting.
- Substantially completed a review of the Foundation's Strategic Positioning, including recommendations around knowledge sharing convening, and other services that add value beyond grantmaking.

### **GOAL 3: Enhance organizational effectiveness**

#### **Achievements:**

To help ensure a continuing high level of effectiveness in OTF's governance, business, communications and granting practices, in 2008/09 the Foundation:

- Carried out its annual grantee compliance audit which complements the Foundation's monitoring of every grant – as well as an audit of declined grant files, and implemented recommendations from previous internal audit reports.
- Completed a risk-based assessment of the Foundation and its granting practices (as required under the government's Transfer Payment Accountability Directive).
- Maintained a high ranking as a cost-effective foundation.
- Continued work on the multi-year Business Process Transformation project to enhance OTF's
  grantmaking capacity by increasing the efficiency of its granting processes and administrative
  systems, through electronic service delivery and related functions.
- Maintained and enhanced the Foundation's pro-active communications strategy. Specific
  achievements included the facilitation of more than 770 grantee recognition events, more
  than \$1.7 million value in earned media coverage, and an award for the OTF Small Towns: Big
  Impact report from the Council on Foundations.
- Refined OTF's pandemic response plan and began internal testing and training.

### **Our Granting Priorities**

The Foundation will support the building of healthy and vibrant communities through community-based initiatives that strengthen the capacity of organizations in the arts and culture, environment, human and social services and sports and recreation sectors.


In particular, the Foundation will place priority on supporting organizations that work in the following areas to help Ontarians achieve their potential.

#### **Enhanced success for students and learners**

A healthy and vibrant community depends on the skills and knowledge of its members.

Whether knowledge and skills are developed in the early years when children start school or much later in life, it is key that people of all ages and abilities are ready to learn. This is why the Ontario Trillium Foundation will place priority on initiatives that:

- Provide community-based learning opportunities and create conditions for achievement for people of all ages and abilities; and
- Help prepare children and youth for success.



#### Healthier and more physically active Ontarians

Encouraging Ontarians to lead healthier lifestyles, as well as improving other determinants of health, such as air and water quality, and providing opportunities for people to enhance their health and well-being will lead to healthier and more physically active Ontarians. To this end, the Ontario Trillium Foundation will place priority on initiatives that:

- Promote physical activity for people of all ages and abilities;
- Promote recreational activities for people of all ages and abilities;
- Enhance and help protect human and ecosystem health;
- Create conditions for people to reach their full health and well-being potential; and
- Promote cultural and artistic activities for people of all ages and abilities.

#### **Our Granting Priorities (Continued)**

This includes, but is not limited to, promoting and increasing physical activity; increasing or sustaining recreational and leisure opportunities; helping communities take responsibility to protect the natural environment; supporting systems that sustain health and well-being; sustaining a healthy arts community; and celebrating and preserving heritage.

#### Enhanced employment and economic potential for workers and their families

The Ontario Trillium Foundation supports initiatives that are innovative and that stimulate economic growth. To this end, OTF will place priority on proposals that support organizations to build skills, create jobs and enhance economic potential for individuals and communities through initiatives that:

- Provide skill development or employment opportunities;
- · Sustain and promote a greener economy and community;
- · Strengthen the economic health of a community; and
- Help further a community's long-term vision and growth.

This includes, but is not limited to, increasing opportunities for employment for those experiencing barriers including Aboriginal people, newcomers, people with disabilities and at risk youth; strengthening organizations and supporting initiatives that promote a sustainable environment; sustaining the economic viability of the community; and encouraging community planning processes.



#### More effective volunteers and more people engaged in their communities

Volunteers are the foundation of healthy and caring communities that are safe, clean, secure and vibrant. Providing people with opportunities to actively participate in activities or programs offered within their community also contributes to this. We support initiatives that:



- Create conditions to increase community engagement of people of all ages, abilities and cultures;
- Strengthen volunteerism among people of all ages, abilities and cultures; and
- Strengthen the voluntary sector.

This includes, but is not limited to, building community connections and awareness; promoting and increasing volunteerism, particularly among young people; enhancing the capacity of the volunteer sector and fostering strategic thinking and innovation; and building the capacity of charitable and not-for-profit organizations.


#### **Featured Grants**

#### **OTF Grants Reflect Cultural Mosaic**

The Ontario Trillium Foundation prides itself on supporting creative initiatives that respond to the real needs of Ontario's varied and evolving communities. With more than one-quarter of all Ontario residents born outside of Canada as of 2006 and with immigrant numbers on the rise, the need to support Ontario's diverse and dynamic communities is essential.

In 2008, the Foundation awarded grants to cultural groups throughout the province and across our four

funding sectors: Arts and Culture, Human and Social Services, Sports and Recreation and Environment. The following grants reflect the cultural diversity of OTF's granting and the worthwhile initiatives having an impact in Ontario communities.



#### Province-Wide

#### **Environment & Diversity Project c/o Sustainability Network**

Grants from the Ontario Trillium Foundation have often been on the leading edge, helping to effect change and create new possibilities. Such is the case with a grant to this province-wide collaborative group, which seeks to improve ethnocultural diversity within Ontario's environment sector.

A grant for \$112,000 will allow this group to place ethnoculturally diverse professionals in environmental not-for-profit organizations. This will represent and engage diverse communities in environmental programs. An additional \$352,000 from the OTF Future Fund will also help to inspire environmental non-profits to

diversify their audience and organizations by providing a multi-level initiative that will lead to long-term sector transformation.

#### Niagara

#### **Neto Hatinakwe Onkwehowe Native Arts**

Aboriginal art is an exciting field and an emerging art market that has truly arrived over the last decade. This group provides arts services to both Aboriginal and non-Aboriginal community members in the Niagara region, and acts as an advocate and promoter of Aboriginal artists in the area.

OTF is helping Neto Hatinakwe Onkwehowe Native Arts to increase Aboriginal cultural support, awareness and programming throughout Niagara thanks to a \$65,300 grant. By hiring a researcher, writer and graphic designer this group will be able to develop and deliver an Aboriginal arts-and-culture education program for the Niagara community.

#### Waterloo, Wellington, Dufferin

#### **Planned Parenthood Waterloo Region**

Women who come from war zone areas, such as Sudan and Afghanistan, come to Canada with substantially different and pressing needs, and face additional barriers compared to newcomers from non-war zone areas. Many of these women have been victims of rapes and sexual assaults and are left to deal with huge emotional and physical trauma on their own.

Planned Parenthood Waterloo Region understands this reality and is helping them cope with the support of an OTF grant for \$44,100. The organization is providing these women with sexual health workshops in safe spaces, which are designed to meet their particular needs and provide individual support through peers and co-facilitators.



#### Toronto

#### **IMPACT (Indian & Performance Art Collective of Toronto)**

Too often, youth at-risk find themselves involved with guns and gangs simply because they lack access to other creative and physical outlets. IMPACT is a group that's truly making a difference in their community by promoting physical and mental health, and diffusing aggression while teaching disciplines that have relevance to many of their participants' cultural heritage.

With the support of an OTF grant for \$125,300, IMPACT is promoting physical and mental health by teaching South Asian performance and martial arts to youth at risk.

#### Champlain

#### Comité d'action local Rideau-Vanier a/s Centre des services communautaire Vanier



One of OTF's granting priorities is to encourage Ontarians to lead healthier and more physically active lifestyles and this Francophone collaborative group is doing just that. With a mission to help Vanier residents improve their physical, mental and economic well-being, Comité d'action local Rideau-Vanier a/s Centre des services communautaire Vanier will build partnerships to enhance physical activity programming and promote healthy, active living with the help of a \$100,000 OTF grant.

Children aged 4 – 12 years will have the opportunity to participate in soccer, swimming, day camps and organized physical activities as a result.

#### Halton-Peel

#### **Senior Tamils Society of Peel**

The Tamil community is a relatively new community in Peel with much of the population being refugees from the civil war in Sri Lanka. Integration into the Canadian way of life can be a harrowing experience however the Senior Tamils Society of Peel is helping smooth the transition for seniors in their local Tamil community with support from OTF.

A grant for \$139,300 will pay for a project co-ordinator, space and equipment to help Tamil seniors overcome isolation. Outcomes will include increased volunteerism, participation in recreation and fitness programs and education about environmental issues.

#### Grey, Bruce, Huron, Perth

#### Maadookii Seniors Centre

Even small grants can have a big impact, and no one knows this better than the Maadookii Seniors centre. An OTF grant for \$15,000 is helping with renovations to this group's seniors centre to improve accessibility, energy efficiency and safety. Upgrades will help to increase participation of First Nation elders in all cultural activities as a result.

Whether in the streets of our major cities or in the most remote parts of our province, OTF is helping to build healthy and vibrant communities of all kinds.



#### Province-Wide

#### Association francophone de parents et d'enfants dyslexiques

The only French language organization of its type in Ontario, Association francophone de parents et d'enfants dyslexiques is providing vital support to parents and teachers dealing with children who have learning disabilities often caused by some form of dyslexia.

With the help of an OTF grant for \$26,000, this group will develop a strategic plan, increase the efficiency of its website and provide the necessary support to this provincial organization and its capacity to offer support to Francophone children who have learning disabilities and to their teachers and parents.

#### **Featured Grants (Continued)**

#### Future Fund grants brighten Ontario's future

In 2007 the Ontario Trillium Foundation introduced a \$2 million Future Fund program to enhance the future of Ontario's communities. In its first year the fund supported the growth and effectiveness of the environment sector in Ontario.

In 2008, \$2 million was again provided through the Future Fund to continue to build the leadership and capacity of the environment sector. An additional \$2 million was also provided for a new initiative to benefit groups creating innovative economic opportunities in Ontario.

The following grants represent two of the groundbreaking initiatives that received funding this year:

#### **Environment Part 2**

#### FarmON Alliance c/o FarmStart



Ontario's agricultural food sector is receiving support it needs to sustain and grow. FarmON Alliance will build a provincially co-ordinated alliance to support a new generation of ecological locally-focused farmers with the support of a Future Fund grant of \$448,900. The initiative will address the issues of farmland access and succession, knowledge transfer, training and resources for new farmers. A number of current environment issues will also be addressed, including food security, farmland protection, urban sprawl, pollution prevention and human health.

The agricultural food sector will also work together to support new farmers through regional workshops, new farmer resources, mentorship and new relationship opportunities between new farmers and farmland owners.

Other organizations involved in this initiative include: FarmStart (Guelph), Ontario Farmland Trust (Guelph), Everdale Farm and Environmental Learning Centre (Hillsburgh), Kawartha Heritage Conservancy (Peterborough), Just Food (Ottawa), Eat Local Sudbury (Sudbury), L'Union des cultivateurs franco-ontariens – UFCO (Ottawa).

#### **Creating Innovative Economic Opportunities**

#### **LASI World Skills**

Every year, 2,500 immigrants, refugees and newcomers turn to Ottawa's LASI World Skills, the coalition of Local Agencies Serving Immigrants for help integrating into Canadian society. Understanding the barriers many newcomers face in securing employment, the agency provides language training, employment counselling and a host of services to help them adapt to the Canadian job market and to gain employment.

A Foundation grant for \$500,000 is supporting LASI's effort to eliminate systemic barriers and enhance the ability of employers in the public, corporate and nonprofit sector to recruit, hire, orient and retain internationally trained workers.




#### OTF OVERALL GRANTS BY PRIORITY From April 1, 2008 to March 31, 2009


#### OTF OVERALL GRANTS BY SECTOR From April 1, 2008 to March 31, 2009

#### FINANCIAL REPORT

# Report on Financial Performance

Ontario Trillium Foundation, March 31, 2009

- In 2008-2009, the Ontario Trillium Foundation received \$110.0 million from the Ministry of
  Culture for its granting programs. (\$111.3 million is recorded in the Statement of Operations; the
  difference came from Deferred Contributions, from underspending in previous years.) Other
  revenue sources include investment income (\$4.1 million), funds made available as a result of
  rescinded grants (\$1.8 million), and \$160,000 from the Ministry of Citizenship and Immigration for
  a funding partnership to be carried out in the following year.
- Of this funding, \$104.6 million was pledged for grants, and grantmaking expenses, services to the community, support services, and amortization together amounted to \$12.6 million.
- At March 31, 2009, the Foundation held approximately \$108.9 million in investments, in fixed income securities (short-term treasury bills and bankers' acceptances). Most of these funds (\$104.0 million) are committed to multi-year grant pledges. The Foundation's investments are managed by the Ontario Financing Authority.
- Funds may be recovered, or future payments rescinded, in cases where circumstances (e.g. planned activities, budgets) change or where grant conditions or performance objectives are not met.
- Accumulated net assets at year-end totaled almost \$2.6 million, of which approximately \$800,000 was invested in capital assets and \$1.8 million represented unrestricted assets.
- Volunteers make a significant contribution to the operations of the Foundation. Given the difficulty
  of estimating the monetary value, these contributions are not reflected in the financial statements.
- In April 2009 the Foundation received funds from the Ministry of Culture in the amount of \$120 million, representing an increased level of funding over the previous year.

Notes to Financial Statements

Year ended March 31, 2009

The Ontario Trillium Foundation (the "Foundation" or "OTF"), an agency of the Ministry of Culture (the "Ministry"), is financially supported by the Ontario government. OTF began operations as an arm's-length agency of the Ontario government on August 23, 1982 and was incorporated without share capital under the laws of Ontario under letters patent dated November 17, 1982. OTF's purpose is to build healthy and vibrant communities throughout Ontario, by strengthening the capacity of the voluntary sector through investments in community-based initiatives.

Government funding is subject to Memoranda of Understanding that define how the funds must be invested and distributed.

#### 1. Significant accounting policies:

These financial statements have been prepared in accordance with Canadian generally accepted accounting principles applied within the framework of the significant accounting policies summarized below:

#### (a) Revenue recognition:

OTF follows the deferral method of accounting for contributions, which include government funding. Unrestricted contributions are recognized as revenue when received or receivable if the amount to be received can be reasonably estimated and collection is reasonably assured. Externally restricted contributions are deferred and recognized as revenue in the year in which the related expenses are incurred.

Investment income is recorded on the accrual basis.

#### (b) Financial instruments:

Short-term investments, treasury bills and bankers' acceptances are classified as held-for-trading investments. Short-term investments are carried at fair value as determined at the fiscal year end based on market values for the debt securities.

Transaction costs that are directly attributable to the acquisition of investments are not considered significant and are expensed when paid.

Investment purchase and sale transactions are accounted for on the settlement date.

Cash consists of cash on hand and in banks. Cash equivalents are classified as held-for-trading and are carried at fair value.

#### 1. Significant accounting policies (continued):

Accounts payable and accrued liabilities and grants payable are classified as other financial liabilities and measured at amortized cost.

In accordance with the Accounting Standards Board's decision to exempt not-for-profit organizations from the disclosure requirements with respect to financial instruments contained within The Canadian Institute of Chartered Accountants' ("CICA") Handbook Section 3862, Financial Instruments - Disclosures, and Section 3863, Financial Instruments - Presentation, the Foundation has elected not to adopt these standards in its financial statements.

#### (c) Grants:

Grants are recorded as expenses in the year that the Foundation approves the grant.

#### (d) Expenses:

Departmental expenses are allocated between grantmaking and support services based on the percentage of each department's activities devoted to these activities.

#### (e) Capital assets:

Capital assets are recorded at cost less accumulated amortization. Amortization is provided on a straight-line basis over the following periods:

#### (f) Use of estimates:

The preparation of financial statements requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenue and expenses during the year. Actual results could differ from those estimates.

#### 2. Future accounting changes:

The CICA has issued revisions to the Section 4400 series of standards which related to not-for-profit organizations.

Section 4470, Disclosure of Allocated Expenses by Not-For-Profit Organizations, has been added, which requires certain disclosures when fundraising and general support expenses are allocated to other functions. This change will be effective for the year commencing April 1, 2009. The change will enhance the current disclosure requirements but will not change the existing presentation requirements on the statement of operations.

#### 3. Investments:

All investments are in fixed income securities and mature within the next three months (2008 - three months). These investments bear interest from 0.9% to 1.1% (2008 - 1.9% to 3.6%).

The Ontario Financing Authority acts as OTF's investment manager under an investment management agreement that adheres to OTF's policies and procedures governing risk and also includes additional risk concern measures.

Risk management relates to the understanding and active management of risks associated with all areas of the business and the associated operating environment. Investments are primarily exposed to interest rate, credit and market risks. OTF has formal policies and procedures in place to address these risks.

Interest rate risk arises from the possibility that changes in interest rates will affect the value of fixed income securities held by OTF. The Foundation manages this risk by holding debt issued by the Government of Canada and large Canadian banks, and by staggering the terms of the securities held.

#### 3. Investments (continued):

Credit risk arises from the non-performance by counterparties to the investments. This risk is minimized by dealing only with creditworthy counterparties.

Market risk arises as a result of trading fixed income securities. Fluctuations in the market expose OTF to a risk of loss. The Foundation mitigates this risk through controls to monitor and limit concentration levels.

These funds are restricted until grants are approved by the Board and pledged to third parties. OTF has controls in place to ensure that the restrictions are met prior to utilization of these funds.

#### 8. Indemnification of officers and directors:

OTF has indemnified its past, present and future directors, officers, employees and volunteers against expenses (including legal expenses), judgements, and any amount actually or reasonably incurred by them in connection with any action, suit or proceeding in which the directors are sued as a result of their service, if they acted honestly and in good faith with a view to the best interests of OTF. The nature of the indemnity prevents OTF from reasonably estimating the maximum exposure. OTF has purchased directors' and officers' liability insurance with respect to this indemnification.

#### 9. Financial instruments:

The carrying values of cash, accounts payable and accrued liabilities and grants payable approximate their fair values due to the relatively short periods to maturity of these items or because they are receivable or payable on demand.

The fair value of investments and related risks are disclosed in note 3.
